Potential Health Effects
Contact with water causes formation of phthalic acid, which is responsible for the corrosive effects. Corrosive effects may be delayed several hours.
Inhalation:
Inhalation of vapor, fume or dust is a primary irritant. Coughing, choking, as well as headache and dizziness can occur. May cause allergic respiratory reaction.
Ingestion:
Corrosive. Swallowing can cause severe burns of the mouth, throat, and stomach. Can cause sore throat, vomiting, diarrhea.
Skin Contact:
Corrosive. Symptoms of redness, pain, and severe burn can occur. May cause allergic skin reactions.
Eye Contact:
Conjunctival edema and corneal destruction can occur. Symptoms include pain, tearing, and photophobia.
Chronic Exposure:
Chronic exposure by inhalation or skin contact can cause allergic sensitization. Causes liver and kidney effects in laboratory animals.
Aggravation of Pre-existing Conditions:

Explosion:

Fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard. Minimum explosive dust concentration: 0.015 ox/ft³. The ignition temperature for the dust cloud is 1202F (650C). Inerting air with CO₂ to below 14% oxygen will prevent dust explosions..

Fire Extinguishing Media:

Water spray, dry chemical, alcohol foam, or carbon dioxide. Water or foam may cause frothing.

Special Information:

In the event of a fire, wear full protective clothing and NIOSH-approved self-contained breathing apparatus with full facepiece operated in the pressure demand or other positive pressure mode.

9. PERSONAL PROTECTION MEASURES: Ventilation System:

A system of local and/or general exhaust is recommended to keep employee exposures below the Airborne Exposure Limits. Local exhaust ventilation is generally preferred because it can control the emissions of the contaminant at its source, preventing dispersion of it into the general work area. Please refer to the ACGIH document, Industrial Ventilation, A Manual of Recommended Practices, most recent edition, for details.

Personal Respirators (NIOSH Approved):

Skin Protection:

17. HANDLING & STORAGE: Keep in a tightly closed container, stored in a cool, dry, ventilated area. Protect against physical damage. Isolate from any source of heat or ignition. Reacts with moisture to give phthalic acid, which can corrode metals liberating hydrogen. Avoid dust formation and control ignition sources. Employ grounding, venting and explosion relief provisions in accord with accepted engineering practices in any process capable of generating dust and/or static electricity. Empty only into inert or non-flammable atmosphere. Emptying contents into a non-inert atmosphere where flammable vapors may be present could cause a flash fire or explosion due to electrostatic discharge. Containers of this material may be hazardous when empty since they retain product residues (dust, solids); observe all warnings and precautions listed for the product.
